

## Georgia Youth in Crisis Train the Trainer Application

Recognizing the need for specialized law enforcement training that is focused exclusively on youth, the Models for Change Mental Health/Juvenile Justice (MH/JJ) Action Network, supported by the John D. and Catherine T. MacArthur Foundation, developed the Crisis Intervention Training for Youth (Youth in Crisis). The training is designed to be administered by a team of instructors, both mental health professionals and law enforcement, with relevant subject matter expertise, experience to lead, and regional knowledge. These instructors include:

- Law enforcement officers who have previously undergone standard CIT training, who understand the basic principles and concepts of CIT, and who are POST IT certified. This is an approved POST credit course.
- Mental health professionals with clinical expertise in adolescent mental health and experience in training.
